

## Claiming Tax Deductions

If you itemize deductions on your federal tax return, you are entitled to claim a charitable deduction for your donation to Goodwill. Use the list of average price ranges below as a guide in determining the value of your donation. Values are based on items in good condition and may vary from one market area to another.
