Goodwill assists senior citizens with online pre-registration for COVID-19 vaccine

Goodwill is helping those over 65, who are eligible for the COVID-19 vaccine, to navigate the pre-registration website myvaccine.fl.gov. The State recently launched the statewide website in an effort to assist Florida residents in scheduling their vaccination appointments. But, not all seniors have access to computers or the knowledge on how to navigate the online system and properly complete the application. Goodwill Community Resource Center (CRC) coordinators typically offer digital skills training to the SWFL community.

“Helping people navigate online applications for assistance is one of the services our CRC coordinators offer on a daily basis,” states Carolyn Johnson, the Sr. VP of Development and Mission Services. “It makes sense for our Goodwill coordinators to offer assistance for our older community members who may not be tech savvy. We can make the application process easier for them.”
